# What data do we collect?

One-Grain collects the following data on our website - one-grain.co.uk:

- Personal identification information
  - Name
  - Email address

# One-Grain collects the following data when the extension is downloaded and active:

• Clicks and keystrokes from within the browser window.

# How do we collect your data?

You directly provide One-Grain with the data we collect. We collect data and process data when you:

- Register on the website for our newsletter Name and Email
- Download the web-extension and it is activated Clicks and Keystrokes
- Download the web-extension and register for an account Name, Email, Clicks and Keystrokes

### How will we use your data?

One-Grain collects your data so that we can:

- Donate grains corresponding to your clicks and keystrokes when the extension is activated.
- Email you with updates on our donations, technical developments and offers.

If you agree, One-Grain will share your data with our partner companies so that they may offer you their products and services.

When One-Grain processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

#### How do we store your data?

One-Grain securely stores your data within a secured database hosted within the cloud. We have all required and appropriate security measures in place as required by law. One-Grain will keep your personal data for 36 months. Once this time period has expired, we will delete your data by automated process.

#### **Marketing**

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop One-Grain from contacting you for marketing purposes or giving your data to other members of the One-Grain Group.

#### What are your data protection rights?

- The right to access You have the right to request One-Grain for copies of your personal data. We may charge you a small fee for this service.

- The right to erasure You have the right to request that One-Grain erase your personal data, under certain conditions.
- The right to restrict processing You have the right to request that One-Grain restrict the processing of your personal data, under certain conditions.
- The right to object to processing You have the right to object to One-Grain's processing of your personal data, under certain conditions.
- The right to data portability You have the right to request that One-Grain transfer the data that we have collected to another organization, or directly to you, under certain conditions.
